MEMORANDOM OF ASSOCIATION :

The name of the Sanstha shall be Mahatma Phule Shikshan Sanstha, Urun - Islampur AIMS AND OBJECTIVES :

- 1 (a) The Sanstha shall study the educational needs of the village town, city, taluka or district as the case may be.
- (b) The Sanstha shall raise and create interest in the people to meet the educational needs by doing the activities explained in the following item No.3 of the aims and objectives of the sanstha by propanganda, meetings, discussions.
- (c) The Sanstha shall establish and run different educational institutes, of different educational stages. The Sanstha shall conduct different courses in different educational fields. The Sanstha shall help deserving students to continue their studies.

Thus Sanstha shall strive tirelessly (a) to help community in the education (b) to bury the backwardness and ignorance (c) to raise the educational standards.

RULES & REGULATIONS :-

Chapter I

EXPLANATION OF TERMS :

SECTION I : The Sanstha shall mean the Mahatma Phule Shikshan Sanstha, Urun- Islampur (Dist- Sangli)

; The General Body shall mean the meeting of the members of the Sanstha.

SECTION III: The Managing Council shall mean the Managing Council of the Sanstha.

SECTION 4.

ear (a) to discuss and pass the reports prepared by the Managing Council

- (b) To elect the General Secretary and twelve members inculding the president and vice president of the Managing Council once in every five years.
- (c) To transact any other business fixed by the Managing Council. Equorum shall be one fifth of the total number of the members of the sanstha.

SECTION 6 :-

There shall be a Managing Council which shall consist of the following :-

- (a) Twelve memberginculding the President & Vice President elected by the General Body.
- (b) The General Secretary elected by the General Body.
- (c) Out of the Ewo members to be Co-Opted by the managing council, One representing the teaching and the other representing non teaching staff in the service of the sanstha. The tenure of the managing council. shall be five years, however, the managing council shall continue in office until the new one is elected in its place. The quorm shall be one third of the total number of the members of managing council.

SECTION 7 :-

The powers and functions of the Managing Council shall be as follows. :-

- i) The Managing Council shall be in charge of the day to day administration of the Institutions conducted by the Sanstha.
- ii) It shall frame the bye-laws for the transation of the business and for carrying out its duties.
- iii) It shall appoint, promote, dismiss, demote, transfer or depute the the members of the staff of the Institutions of the Sanstha.
- iv) It shall raise funds for meeting the expenses incurred by the Sanstha.
 - v) It shall keep the accounts of the Sanstha and shall submit the report of the educational activities to the General Body.
- vi) In case the post of the General Secretary falls vacant on any account, the Managing Coucil shall have power to appoint a General Secretary, till the said post is filled by election, as laid down in Section 6 (b)
- vii) In case any member of the managing council ceases to be a member on any account the managing council shall have power to Co-Opt :

a new member for the remaining term of the managing council. D-11-11/N

SECTION 8 :- OFFICERS OF THE SANSTHA:

There shall be a President, Vice President and General Secretary of the Sanstha. All of them shall be elected by the General Body, in its meeting. In case of voting it shall be by ballot. The tenure of all these officers shall be five years, However, they shall remain in their respective office, until the new officers are elected to take their respective places.

SECTIONS 9) :-

The powers and functions of the General Secretary shall be as follows: -

- i) The General Secretary shall be the Chief Executive officer of the Sanstha.
- ii) He shall have power to execute the decisions of the Managing Council.
- iii) He shall have powers to operate the Bank-accounts of the Sanstha subject to the control of the Managing council_
- iv) He shall maintain the accounts of the Sanstha, get them audited and submit the same to the General Body J
- v) He shall act as the Secretary of the Managing Council.

SECTION (10) :- (FINANCIAL MATTERS)

- The Sanstha shall raise funds by subscriptions,
 - ibutions, donations, Loans (including all types of . the Banks) fees & fines, grant-in-aid from persons, bodies private & public. The General Secretary shall spend money on the activities, of the Sanstha with the confirmation of the managing council. The General Secretary shall deposit and withdraw money in the name of the Sanstha.
- SECTION (11) : E: (AMENDMENT TO THE RULES & REGULATION S:-Any amendment to the rules and regulations of the Sanstha shall be passed by two third majority of the members of the General Body, present and voting.
- SECTION (12) : DISSOLUTION :-

The General Body of the Sanstha shall be disloved by 2/3rd majority of the members of the General Body. All rights: and obligations in case of the dissolution of the Sanstha shall be endowed to any other educational Institutions with

the approval of the General Body.
